

ICAS 管理体系认证证书及其认证标志的使用规则

Rules for use of ICAS management system certificate and mark

1. 范围 Scope

本文件规定了客户获得 ICAS 认证证书后使用 ICAS 认证证书及其认证标志的规则。This document specifies the rules for the use of the ICAS certificate and certification mark after the customer has obtained the ICAS certification.

3. 术语和定义 Terms and definitions

3.1 ICAS 管理体系认证证书: 由 ICAS 颁发, 作为一个客户的管理体系已经过 ICAS 认证并注册的证明。ICAS Management System Certification certificate: Issued by ICAS as proof that a management system of client has been certified and registered by ICAS.

3.2 ICAS 管理体系认证标志: 由 ICAS 授予, 仅供获得 ICAS 管理体系认证的特定客户使用, 用以表明客户的管理体系经过 ICAS 认证并注册的一种图形和标识。ICAS Management System Certification Mark: Issued by ICAS, a graphic and logo to proof that a management system of client has been certified and registered by ICAS and used for the specific customer who has obtained ICAS management system certification

3.3 ICAS 机构徽标: 代表 ICAS 机构的特定图形和标识。ICAS logo: a specific image and logo which represents the ICAS

*注: ICAS 拥有该徽标的所有权和使用权, 被认证的客户不能单独使用, 只能使用 ICAS 提供的 ICAS 认证标志。Note: ICAS has the ownership and right to use this logo which can not be used by certified customer by itself. Certified customer can only use ICAS certification mark provided by ICAS.

5. ICAS 认证证书及其认证标志的使用要求 (不含已获 ISO 9001 及 GB/T 50430 双标认证的客户因参与境外投标工作需再单独颁发的 ISO9001 证书及其认证标志) Requirements for the use of ICAS certificate and certification mark (excluding the ISO9001 certificate and its certification mark that need to be issued separately by customers who have already obtained the dual standard certification of ISO 9001 and GB/T 50430 for participation in overseas bidding work).

5.1 ICAS 授权获证客户只能在证书有效期内以及已获认证的范围内, 依据本文件规定, 有条件使用 ICAS 认证证书及其认证标志, 获准使用的认证标志必须完整, 不得将其变形使用。ICAS 对获证客户是否正确使用认证证书及其认证标志进行监督审核。ICAS authorized certified customers shall only use the certification certificate & certification mark with conditions within the validity of the certificate and the scope of certification. Certification mark shall remain intact and not be altered when use. And ICAS would supervise if the certificate holder uses the certification certificate & certification mark correctly.

5.2 ICAS 的认证证书及其认证标志可以展示在文件、网站、已被认证的工作场所、销售场所、广告和宣传资料中, 但不可利用管理体系认证证书和相关文字、符号, 误导公众认为认证证书覆盖范围外的管理体系, 或产品、服务获得了认证。企业必须在使用标识的同时, 声

明本企业通过相应的管理体系认证,不得误导使用者认为该标识为产品认证标识或服务认证标识。Certification certificate and certification mark of ICAS can be displayed on the document, website, and certification work place and selling place, advertisements and promoting materials. But not to use the management system certification and related words, symbols to mislead the public that the certificate covers the scope of the management system, or products, services have been certified. Enterprises must declare that the enterprise had obtained the appropriate management system certification when use the certification logo at the same time, and shall not mislead the user to believe that the logo for product or service certification.

5.3 获证客户可以在相应的管理体系认证证书覆盖的业务范围内在相关场合有条件的使用 ICAS 认证标志。如在有关文件、办公场所、销售场所和出版物上使用。组织在产品上、运输包装上、广告中使用 ICAS 认证标志时,必须符合以下要求: The certified client can use the ICAS certification mark conditionally on relevant occasions within the business scope covered by the corresponding management system certification certificate. For example, use on relevant documents, office sites, sales sites and publications. When use the ICAS certification mark on products, on transport packaging and in advertisements, the following requirements must be met:

注: Note

*1: “产品”指是一个有形的产品或在单个包装箱、容器里的产品;对于从事测试/分析活动的组织,其产品也可以指一份测试/分析报告。‘Product’ means a tangible product or a product in a single box or container; in the case of an organization engaged in testing/analysis activities, product may also mean a test/analysis report.

*2: “包装箱”指如薄纸板等作成的外包装。一般判别标准是其可从产品上移除且不会导致产品分解、碎裂或损坏。‘Packaging Box’ means an outer packaging such as thin cardboard. The general criterion is that it is removable from the product and does not cause the product to disintegrate, crumble or be damaged.

*3: 认证标识的样式见本规则 4。The style of the certification mark is described in clause 4 herein.

*4: 例如: 在标识旁边清楚说明: “本企业(生产该产品)的质量管理体系已经通过 ISO9001: 2015 认证。” For example, next to the logo it clearly states, ‘The quality management system of this company (which produces this product) has been certified to ISO 9001:2015.’

5.4 ICAS 不允许获证客户将 ICAS 认证标志用于实验室检测、校准或检验的报告或证书。ICAS shall not permit its marks to be applied by certified clients to laboratory test, calibration or inspection reports or certificates.

6 已获 ISO 9001 及 GB/T 50430 双标认证的客户,因参与境外投标工作需再单独颁发的 ISO9001 证书的使用要求 Requirements for the use of the ISO9001 certificate issued separately by the customer who has obtained the dual standard certification of ISO 9001 and GB/T 50430 for participation in overseas bidding work.

已获 ISO 9001 及 GB/T 50430 双标认证的客户因参与境外投标工作需再单独颁发的 ISO9001 证书不能在中国境内使用和展示。Customers who have been awarded ISO 9001 and GB/T 50430 dual standard certificates cannot use and display their ISO 9001 certificates in China because they are involved in overseas bidding work and need to issue separate ISO 9001 certificates again.

7. 认证标志的复制方式 The copy method of certification mark

7.1 获得 ICAS 认证的客户只能使用与 ICAS 所提供色调一致的彩色认证标志或黑白认证标志。ICAS 提供认证标志的硬拷贝或电子版。Once the customer has obtained the ICAS certification, it can only use the colored certification mark that has the same color tone as the ICAS one or black and white certification mark. ICAS shall provide hard copy or electrical copy of the mark.

7.2 认证标志图样可按比例放大或缩小,但字迹必须清晰。The certification mark can be enlarged as well as reduced in proportion, as long as the text remains legible.

8 ICAS 规定获证客户在使用认证证书及认证标志时应符合以下要求,否则 ICAS 有权中止或撤销客户对认证证书或认证标志: ICAS stipulates that certified clients should meet the following requirements when using the certification certificate and certification mark, otherwise ICAS has the right to suspend or revoke the client's certification certificate or certification mark:

8.1 在传播媒介(如互联网、宣传册或广告)或其他文件中引用认证状态时,应符合本规则

的要求; Conforms to the requirements of the certification body when making reference to its certification status in communication media such as the internet, brochures or advertising, or other documents;

8.2 不做出或不允许有关于其认证资格的误导性说明; Does not make or permit any misleading statement regarding its certification;

8.3 不以或不允许以误导性方式使用认证文件或其任何部分; Does not use or permit the use of a certification document or any part thereof in a misleading manner

8.4 在其认证被撤销时, 按照 ICAS 的指令立即停止使用所有引用认证资格的广告材料; upon withdrawal of its certification, discontinues its use of all advertising matter that contains a reference to certification, as directed by ICAS

8.5 在认证范围被缩小时, 修改所有的广告材料; Amends all advertising matter when the scope of certification has been reduced;

8.6 不允许在引用其管理体系认证资格时, 暗示认证机构对产品 (包括服务) 或过程进行了认证; Does not allow reference to its management system certification to be used in such a way as to imply that the certification body certifies a product (including service) or process;

8.7 不得暗示认证适用于认证范围以外的活动和场所; Does not imply that the certification applies to activities and sites that are outside the scope of certification;

8.8 在使用认证资格时, 不得使 ICAS 和 (或) ICAS 的认证制度声誉受损, 失去公众信任。

Does not use its certification in such a manner that would bring ICAS and/or certification system into disrepute and lose public trust.

9. 一旦发现获证客户违反上述规定, 错误使用证书和标志, ICAS 将根据情况的严重性采取适当的措施, 包括立即整改、暂停认证、撤销认证、在认证机构公开的媒体上发布澄清声明等。获证客户应立即中止上述行为并消除错误使用认证标识造成的不良影响, 否则将承担必要的法律和经济责任。Once it is found that the certified clients violates the above provisions and uses the certificate and logo incorrectly, ICAS will take appropriate measures according to the seriousness of the situation, including immediate rectification, suspension of certification, revocation of certification, and publication of clarification statements in the public media of the certification body. The certified clients shall immediately suspend the above actions and eliminate the adverse effects caused by the wrong use of the certification mark; otherwise it will bear the necessary legal and financial responsibility.
